Rather, *The Constitution of Liberty* is the culmination of four decades of reflection on the nature of economic, political and social life and the possibility of a free society. As Professor Miller cogently argues and illustrates, its three parts comprise a careful argument that runs through the book from beginning to end. Part I, "The Value of Freedom", provides the philosophical foundation and justification of a free society and defence against the major contemporary opponents of such a society. In Part II, "Freedom and the Law", Hayek provides an account of the development of the Rule of L
