As the utopia of the "end of history"<sup>TM</sup> falters, the rhetoric of security and risk, of crisis in the relation between financial markets and sovereign states, of perpetual war, and of corruption in politics brings about a relentless desire for law and constitutional reform. These expectations, however, are often at odds with the way contemporary social and political theories, and a growing number of constitutional law specialists, decision by constitutional politics, not by constitutional law. Suffused by constitutional issues, nineteenth-century politics had a different character than they had during most of the time we have lived through. For most of the twentieth century, jurists distinguished politics from law. The judicial branch of government set the boundaries within which the political branches of government could.<sup>5</sup> Constitutional scholars were beginning to recognize that the distinction between politics and law was overstated even as the twentieth century ended.<sup>5</sup> Today, in the ear of the Tea Party, one would have to be blind to adhere to such a simplistic distinction.
