The National Labor Relations Act created the National Labor Relations Board, a government body that provides oversight for collective bargaining and the creation of unions. In addition, the NLRB investigates labor abuses, union concerns, and disputes. The NLRB conducts secret ballot elections in companies with employees who wish to develop unions. The National Labor Relations Act also protects workers' rights not to join or create unions; union organizers and coworkers cannot pressure others into union creation or membership under the law.
