Transition from Popular Moral Philosophy to Metaphysics of Morals If we have so far drawn our concept of duty from the common use of our practical reason, it is by no means to be inferred from this that we have treated it as a concept of experience. On the contrary, if we attend to experience of people's conduct we meet frequent and, as we ourselves admit, just complaints that no certain example can be cited of the disposition to act from pure duty; that, though much may be done in conformity with what duty commands, still it is always doubtful whether it is really done from duty and the 58 quotes from Groundwork of the Metaphysics of Morals: "Act in such a way that you treat humanity, whether in your own person or in the person of any other..."
