The Vice President is also part of the Executive Branch, ready to assume the Presidency should the need arise. The Cabinet and independent federal agencies are responsible for the day-to-day enforcement and administration of federal laws. These departments and agencies have missions and responsibilities as widely divergent as those of the Department of Defense and the Environmental Protection Agency, the Social Security Administration and the Securities and Exchange Commission. The President is both the head of state and head of government of the United States of America, and Commander-in-Chief of the armed forces. Under Article II of the Constitution, the President is responsible for the execution and enforcement of the laws created by Congress. Fourteen of the former vice presidents became president of the United States—more than half of them after a president had died. One defeated the sitting president with whom he served. One murdered a man and became a fugitive. The stories of these diverse individuals illustrate the development of the vice presidency itself—that colorful, important, and routinely disparaged American political institution.

Constitutional Origins & Structural Changes. Electoral System.

Our Constitution's framers created the vice presidency almost as an afterthought. In setting up a system for electing presidents, they devised an electoral college and provided that each of its members was to vote for two persons, "of whom one at least shall not be an Inhabitant of the same State with themselves."
